1	Use/Indic ation	What is the product indicated for?	<ul> <li>Clinical Particulars</li> <li>Atorvastatin calcium tablets is an HMG-CoA reductase inhibitor indicated as an adjunct therapy to diet to: <ul> <li>Reduce the risk of MI, stroke, revascularization procedures, and angina in adult patients without CHD, but with multiple risk factors.</li> <li>Reduce the risk of MI and stroke in adult patients with type 2 diabetes without CHD, but with multiple risk factors.</li> <li>Reduce the risk of non-fatal MI, fatal and non-fatal stroke, revascularization procedures, hospitalization for CHF, and angina in adult patients with CHD.</li> <li>Reduce elevated total-C, LDL-C, apo B, and TG levels and increase HDL-C in adult patients with primary hyperlipidemia (heterozygous familial and nonfamilial) and mixed dyslipidaemia.</li> <li>Reduce elevated TG in adult patients with hypertriglyceridemia and primary dysbetalipoproteinemia.</li> <li>Reduce total-C and LDL-C in patients with homozygous familial hypercholesterolemia (HoFH).</li> <li>Reduce elevated total-C, LDL-C, and apo B levels in</li> </ul> </li></ul>
2	Dosage	What is the recommended dosage?	pediatric patients, 10 years to 17 years of age, with heterozygous familial hypercholesterolemia (HeFH) after failing an adequate trial of diet therapy.  The recommended starting dose of atorvastatin calcium tablets is 10 or 20 mg once daily. Patients who require a large reduction in LDL-C (more than 45%) may be started at 40 mg once daily.  The dosage range of atorvastatin calcium tablets is 10 to 80 mg
3	Administr ation	How to administer?	once daily.  Take atorvastatin calcium tablets each day at any time of day at about the same time each day. Atorvastatin calcium tablets can be taken with or without food
4	Formulati on	Can tablet be crushed?	No
5	Administr ation	What do I do if I miss a dose?	If you miss a dose of atorvastatin calcium tablets, take it as soon as you remember.  Do not take atorvastatin calcium tablets if it has been more than 12 hours since you missed your last dose. Wait and take the next dose at your regular time. Do not take 2 doses of atorvastatin calcium tablets at the same time.
6	Administr ation	Use in Pediatric Population	In Heterozygous Familial Hypercholesterolemia (HeFH): The safety and effectiveness of atorvastatin calcium has been established in pediatric patients, 10 years to 17 years of age. However, due to Pfizer's marketing exclusivity rights, this drug product is not labeled with that pediatric information
7	Administr ation	Use in Geriatric Population	Since advanced age (≥65 years) is a predisposing factor for myopathy, atorvastatin calcium should be prescribed with caution in the elderly.

9	Mechanis m	Mechanism of Action	Atorvastatin is a selective, competitive inhibitor of HMG-CoA reductase, the rate-limiting enzyme that converts 3-hydroxy-3-methyl glutaryl-coenzyme A to mevalonate, a precursor of sterols, including cholesterol. In animal models, atorvastatin calcium lowers plasma cholesterol and lipoprotein levels by inhibiting HMG-CoA reductase and cholesterol synthesis in the liver and by increasing the number of hepatic LDL receptors on the cell surface to enhance uptake and catabolism of LDL; atorvastatin calcium also reduces LDL production and the number of LDL particles.
