1.	Use/Indication	What is the product indicated for?	 Hypertension Treatment: Lowers blood pressure in adults and children over 6, reducing the risk of cardiovascular events like strokes and heart attacks. Stroke Risk Reduction: Reduces stroke risk in hypertensive patients with left ventricular hypertrophy, though not applicable to Black patients. Diabetic Nephropathy: Treats nephropathy in type 2 diabetes patients with elevated creatinine and proteinuria, and a history of hypertension.
2.	Dosage	What is the recommended dosage?	 Usual Adult Dose: 50 mg once daily. Usual Pediatric Starting Dose: 0.7 mg per kg once daily, up to a maximum of 50 mg. Hypertensive Patients with Left Ventricular Hypertrophy: Usual Starting Dose: 50 mg once daily. If additional blood pressure control is needed, consider adding hydrochlorothiazide 12.5 mg and/or increasing the losartan potassium dose to 100 mg daily. If further response is required, increase hydrochlorothiazide to 25 mg daily. Nephropathy in Type 2 Diabetic Patients: Usual Dose: 50 mg once daily. If further blood pressure control is needed, increase the dose to 100 mg once daily.
3.	Administration	How do I take it?	 ✓ Take losartan potassium tablets exactly as prescribed by your doctor. Your doctor may change your dose if needed. ✓ Losartan potassium tablets can be taken with or without food. ✓ If you miss a dose, take it as soon as you remember. If it is close to your next dose, do not take the missed dose. Just take the next dose at your regular time. ✓ If you take too much losartan potassium tablets, call

4.	Administration	Use in Pediatric Population	Losartan Potassium is not recommended for use in pediatric patients under 6 years of age or in those with a glomerular filtration rate (GFR) of less than 30 mL/min/1.73 m ² .
5.	Administration	Use in Geriatric Population	No significant differences in effectiveness or safety were observed between older and younger patients, although increased sensitivity in some older individuals cannot be ruled out.
6.	Mechanism	Mechanism of Action	Angiotensin II, a potent vasoconstrictor and key hormone in the renin-angiotensin system, plays a critical role in hypertension and stimulates aldosterone release. Losartan and its active metabolite block the effects of angiotensin II by selectively binding to the AT receptor in tissues such as vascular smooth muscle and the adrenal gland. Losartan does not have partial agonist activity at the AT receptor and has a 1000-fold greater affinity for the AT receptor than the AT receptor. The active metabolite is 10 to 40 times more potent and acts as a non-competitive inhibitor. Neither losartan nor its metabolite inhibits ACE or affects other cardiovascular hormone receptors or ion channels.
7.	Warning	Black Box Warning	If pregnancy is detected, discontinue losartan potassium immediately. Drugs that directly affect the renin-angiotensin system can cause harm or death to the developing fetus.
8.	Lactation	Use in Lactation	It is unknown whether losartan potassium passes into breast milk. You should decide between taking losartan potassium or breastfeeding, but not both.
9.	Pregnancy	Use in Pregnancy	 Losartan potassium tablets can cause harm or death to an unborn baby. Talk to your doctor about other ways to lower your blood pressure if you plan to become pregnant. If you get pregnant while taking losartan potassium tablets, tell your doctor right away.
10.	Interaction	Is there any interaction with other medication?	 Agents Increasing Serum Potassium: Risk of hyperkalemia. Lithium: Risk of lithium toxicity. NSAIDs: Increased risk of renal impairment and reduced effectiveness of diuretics, natriuretics, and antihypertensive treatments. Dual Inhibition of the Renin-Angiotensin System: Increased risk of renal impairment, hypotension, syncope, and hyperkalemia.
11.	Storage	What are the storage conditions?	 Store losartan potassium tablets at 59°F to 86°F (15°C to 30°C). Keep losartan potassium tablets in a tightly closed container that protects the medicine from light. Keep losartan potassium tablets and all medicines out of the reach of children.
12.	Dispensing	How to Dispense?	As prescribed by the Physician
